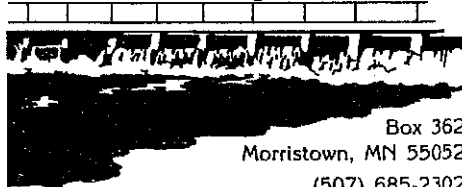

- WHEREAS,** Minnesota Election Law Section 204B.16 subd. L, Polling Places, permits the city to change the location of the city polling places; and
- WHEREAS,** the City of Morristown, in compliance with the Help America Vote Act (HAVA), seeks to provide polling places that are easily accessible to all eligible voters;

THEREFORE, BE IT RESOLVED that the City Council of the City of Morristown, does hereby designate the Morristown City Hall, 402 Division St. S., Morristown, Minnesota, as the Polling Place for the City of Morristown,

BE IT FURTHER RESOLVED, that the designation of the polling place shall take effect for Tuesday, August 14, 2018 Primary Election, if necessary, and for Tuesday, November 6, 2018 General Election.
