Morristown Business Expo held on March 10<sup>th</sup>. There were 27 vendor booths and 169 people registered for Expo Bucks drawing.

Commercial Club annual Community Spring Dinner was held at the Legion Hall on Sunday, March 29. 130 people were served.

Children's Easter Egg Scramble was held on Saturday, April 4<sup>th</sup> at the Community Center. 68 children attended.

## MAY – Regular meeting held

City of Morristown set the Commercial Club Bar yearly liquor license at \$250.00 Donated \$175 start up money to WEM Boy Scouts fundraiser during Dam Days. Twelve new street banners purchased by the Commercial Club are installed. Dam Days – May 29th, 30th, and 31st. Miss Morristown Pageant – Wednesday, May 27. Commercial Club sponsored Queen's reception following pageant. Cake and punch were served. Twilight parade on Friday, May 29th. Commercial Club Beer Garden profit was \$10,500. 175 children attended the Dam Days children's activities.

### JULY - Regular meeting held

The 28<sup>th</sup> annual City-Wide Garage Sale sponsored by the Commercial Club was held on Friday, July 31<sup>st</sup> and Saturday, August 1<sup>st</sup> beginning at 7:30 am each day. Fee - \$10.00 to be registered on map. There were 45 registered sales.

The city of Waterville will be the host city and the cities of Elysian and Morristown will be involved. The Commercial Club will donate the use of the Community Center Banquet Hall for the banquet on May 13<sup>th</sup>, 2017. Events will be held at area lakes; Lake Francis, Sabre Lake, Lake Sakatah, Lake Tetonka and Horseshoe Lake. Letters of support were sent by the governing bodies of each city. Notification of acceptance will be sent in April.

#### AUGUST - Regular meeting held

The Commercial Club members also provided water stations and a pizza supper at Old Town Tavern for the Fireman's Run on Monday, Sept.  $28^{\text{th}}$ .

## OCTOBER - Regular meeting held

Donated \$250.00 to Ducks Unlimited even and \$250.00 to Ducks Unlimited Meat Raffle. Donated \$6190.00 to Fire Department for signage and Maltese Cross emblem on front of new fire station. Members volunteered to work at Haunted Trail even on Friday, Saturday, October 9<sup>th</sup>, 10<sup>th</sup>, 16<sup>th</sup>, 17<sup>th</sup>. 2500 people attended event. Children's Halloween Party – Saturday, Oct. 31. Lots of workers and 100 plus kids.

The Commercial Club provided school employees in the Morristown building with large caramel rolls in appreciation of the staff and in honor of National Education Week.

#### DECEMBER - Regular meeting held

The Commercial Club received \$1500.00 for their share of the Haunted Trail Event. The annual Christmas drawing was held on Saturday, December 12<sup>th</sup>. The Commercial Club donated 10 meat and cheese gift bags for the drawing. 50 gift bags with useful items for senior citizens and shut-ins were packed, 43 were delivered to homes by CC members and the rest were added to the Christmas drawing gifts. 133 households received gifts in the first round for a total of 179 gifts from 33 local area donors.
