

**NOTICE OF FILING FOR THE 2018 GENERAL ELECTION
RICE COUNTY, MINNESOTA
May 2018**

Notice is hereby given that a general election will be held in Rice County on Tuesday, November 6, 2018, for the purpose of electing candidates for the offices listed below. The filing period for all offices begins at 8:00 a.m., Tuesday, May 22, 2018, and ends at 5:00 p.m., Tuesday, June 5, 2018.

Note: Filing offices will be closed Monday, May 28, 2018, in observance of Memorial Day.

Candidates may file in person or by mail if the filing is received during the filing period. Candidates who will be absent from the state during the filing period and meet the requirements of Minnesota Statutes section 204B.09, subdivision 1a, may arrange to file during the seven days immediately preceding the candidate's absence from the state.

The place of filing for federal offices is the Office of the Secretary of State, State Office Building, Room 180, 100 Rev. Dr. Martin Luther King Jr. Blvd., St. Paul, MN 55155-1299. The place of filing for state offices is with the Office of the Secretary of State or with the county auditor of the county in which the candidate resides.
