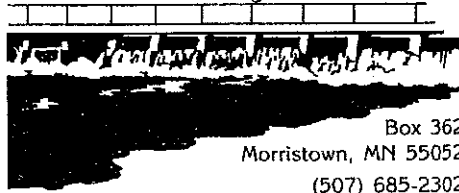

ORDINANCE 2016-7

AN ORDINANCE AMENDING CHAPTER 71 OF THE MORRISTOWN CITY CODE

THE CITY COUNCIL OF THE CITY OF MORRISTOWN DOES ORDAIN:

1. Morristown City Code § 71.001 is hereby created and shall be inserted into Chapter 71 of the Morristown City Code:

“§ 71.001 DEFINITION OF COMMERCIAL VEHICLE

As used in Chapter 71, the term “Commercial Vehicle” shall be defined to include any of the following:

- a. A vehicle that requires a commercial driver’s license (CDL) to operate;
- b. A vehicle with an overall length of 22 feet or more;
- c. A vehicle with a width of 102 inches or more;
- d. A vehicle with an overall height, including any attached apparatus, of 10 feet or more; or
- e. A vehicle with an overall gross vehicle weight (GVW) of 12,000 pounds or more.

The following passenger vehicles shall be excepted from the definition of “Commercial Vehicle”:

- a. Passenger vehicles that are not used for transportation of persons for hire, compensation, or profit;
- b. House vehicles (such as motor homes);
- c. Vanpool vehicles.”

2. Morristown City Code § 71.05 is hereby deleted in its entirety and the following shall be substituted in its stead:


“§ 71.05 PARKING OF COMMERCIAL VEHICLES, TRAILERS, AND RELATED EQUIPMENT.

The following vehicles and equipment shall be prohibited from being parked or stored in a R-1 Residential District, R-M Residential-Mobile Home District, or B-1 Highway Commercial District except when loading, unloading, or rendering a service:


- a. Commercial Vehicles;
- b. Trailers in excess of 30 feet in length;
- c. Construction equipment;
- d. Cargo trucks;
- e. Agricultural equipment.”

3. Morristown City Code § 71.06 shall be and hereby is deleted in its entirety.

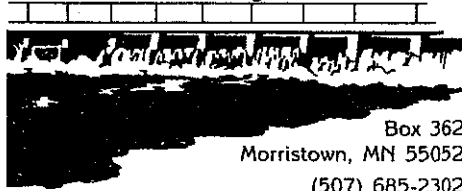

ORDINANCE 2018 – 1


AN ORDINANCE AMENDING SECTION 30.01 (A) OF THE MORRISTOWN CITY CODE TO DESIGNATE A SECOND REGULAR MEETING

THE CITY COUNCIL OF THE CITY OF MORRISTOWN DOES ORDAIN:

1. Section 30.01 (A) of the Morristown City Code is deleted in its entirety and the following is substituted in its stead:


“(A) Regular meetings. Regular meetings of the City Council shall be held on the first Monday and the third Monday of each calendar month at 7:00 p.m. Any regular meeting falling upon a holiday shall be held on the next following business day at the same time and place. The City Clerk/Treasurer shall maintain a schedule of regular meetings. This schedule shall be available for public inspection during regular business hours at the City Clerk/Treasurer’s office.”

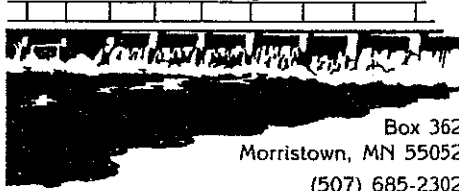

ORDINANCE 2018 – 2 AN ORDINANCE AMENDING SECTION 31.15 OF THE MORRISTOWN CITY CODE ESTABLISHING SALARIES FOR THE MAYOR AND CITY COUNCIL

THE CITY COUNCIL OF THE CITY OF MORRISTOWN DOES ORDAIN:

1. Section 31.15 of the Morristown City Code is deleted in its entirety and the following is substituted in its stead:

“Section 31.15 GENERALLY.
(A) The salary of the Mayor shall be One Thousand Dollars (\$1,000) annually. Said annual salary shall be compensation for performing the duties of mayor, including attendance at the regular council meeting held on the first Monday of each month, whether or not actually attended.


(B) The salary for each council member, excluding the Mayor, shall be Nine Hundred Twenty-Five Dollars (\$925) annually. Said annual salary shall be compensation for performing the duties of council member, including attendance at the regular council meeting held on the first Monday of each month, whether or not actually attended.

(C) In addition to the annual salaries set forth above, the Mayor and each council member shall be paid Twenty-Five Dollars (\$25) as and for compensation for each meeting actually attended in addition to the regular council meeting held on the first Monday of each month, including any work sessions, special meetings, public hearings, emergency meetings, or the regular council meeting held on the third Monday of each month.”
2. The amendments to Section 31.15 set forth in Paragraph 1 are a codification of compensation that has historically been paid to the Mayor and council members and does not constitute an increase in their compensation. Therefore said compensation structure shall be effective January 1, 2018.

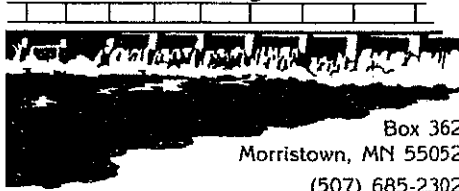
